# RESEARCH FELLOWSHIPS OFFERED

Summer Research Fellowships are available through the Medical College of Wisconsin (awarded to them through a training grant by NIH). There is an opportunity for medical students to conduct research at the Medical College of Wisconsin in the laboratory of a full time member of faculty for a 3 month interval. The stipend consists of \$420.00 per month. Any student in good standing at any medical school at Duke is welcome to apply, the deadline for receipt of applications for the summer of 1983 being March 1, 1983.

## CURRICULUM CHANGES IN THE MAKING

Duke's "New Curriculum" appeared in 1966 and has remained more or less intact to this day. While the overall format of hasic science year, clinical rotations year, and 2 elective years is likely to stay with us, some changes are likely to appear. To help inform medical students what is going on, <u>Shifting Dullness</u> will be running a series of articles on the status of each year's curriculum committee.

In general, students want to keep the curriculum structure as is, with a reshuffling of priorities in the classroom. For example, the first year committee is most interested in the restructuring of the information presented and the amount of time devoted to each of the basic sciences. The second year committee is looking into more hands-on experience for students. The third and fourth year committees want to upgrade the effectiveness of electives and elective selection.

The faculty proposals that have arisen in committee keep within the general framework of the present curriculum, but with a different emphasis than those of the students'. These will be covered in more detail in the articles of the separate years.

# DROP-ADD PROCEDURES CAUSE CONCERN

The Office of Medical Education has sent out a memo stating that from now on, the only time for drop-add will be a two week period at the beginning of each 16 week term. The period will begin before classes start and conclude at the end of the first week of classes. Jeanne Lee in the Office of Medical Education explained that this does not represent a change in the rules but merely a decision to enforce the old rules.

However, the decision is not yet final, according to John Rich, president of the third year class. Because this rule does not allow course changes at the beginning of each eight week or four week period,, there has been some student concern about the rule since many courses start at times other than at the beginning of a 16 week term. Rich said a group of third year students has met with Dr. Christakos to discuss the issue and that Dr. Christakos is looking into the matter.

Logistics are a problem, Rich said, since each drop or add necessitates a change in billing and must go through the bursur's office. "In the past the system has been overloaded with thousands of drop-adds" coming at various points in the term, he said. While it may/be feasable to allow course changes at the start of each four week term, Rich said, "It's not unreasonable to ask for the opportunity to make changes at the start of each eight week period."
