# **Easier Access to Ovid Resources**

A username and password are no longer needed for accessing Ovid MEDLINE, Journals@Ovid, or Books@Ovid. You may link to Ovid from any computer on the Duke campus or attached to the Duke network through VPN.

We are also introducing Ovid's new personal user accounts, available to anyone in the Duke community. As with our current personal accounts, you can save searches and set up autoalerts, but the new accounts offer even more functionality:

- ✓ Accounts provide up to 50MB of storage space
- ✓ You can upload pertinent documents, images, etc., for a project
- ✓ An Ovid toolbar is available for installation in your browser
- ✓ You can save citations from elsewhere into your Ovid project space

These new personal accounts are available now. First, connect to Ovid by using the **MEDLINE Ovid (Generic)** option on the Databases page at **http://www.mclibrary.duke.edu/databases**. Then click on "My Account" at the top right corner of the Ovid main screen. Fill out the form and start using the new features right away.

With the introduction of this new Ovid functionality, the Library will stop supporting our existing system for Ovid personal accounts. No new accounts will be created, and existing accounts will be discontinued as of January 19, 2011.

You DO NOT NEED a username or password unless you want to save search strategies or set up an autoalert within Ovid. Just connect to Ovid from any computer on the Duke network, and you will have access to all the databases, e-journals, and e-books.

If you are currently using saved searches and autoalerts stored in an Ovid personal account, the Library will contact you via email and ask you to do the following by **January 18, 2011**.

- ▶ Create a new Ovid account. Connect to Ovid and click on **My Account** in the top right corner of the Ovid main screen.
- ▶ Send email to mclref@mc.duke.edu with your OLD and NEW Ovid usernames and ask the Library to transfer your autoalerts and saved searches to your new account.

About one week after you contact the Library, your alerts and saved searches will be moved to your new account. Some of these transfers will be slower over the holidays due to limited business hours at Ovid. If you do not see your saved items transferred after a week, please let the Library know via email at mclref@mc.duke.edu.

# Evernote Free Digital Note-taking Application!

If you're swimming in a pile of sticky notes, Evernote (http://www.evernote.com) will provide a whole new way to help you organize various types of information from several different sources. You can create notes of text and photos, clip Web pages, snag screen shots and images, and in some cases, take audio notes. Instead of just saving a bookmarked Web address, Evernote allows you to save the HTML on a Web page as a note, with just the click of a button. This Web Clipper is available as an add on for Firefox, Google Chrome, Internet Explorer, and Safari. All of these items can be stored in your own searchable database that can be accessed from any computer or device that has Internet capabilities.

This software also contains different ways to categorize information. With the "Notebooks" feature, you can keep

track of several projects at once. Evernote is freely available for download from the Web, though you must create an account in order to take advantage of all the features.



# Doodle Free Meeting Scheduler!

Having trouble finding a time when everyone on your team can meet? Is half your team on Exchange while others remain on Lotus Notes? Are you tired of sending out multiple emails to find a time when everyone is free? Doodle (http://www.doodle.com) to the rescue!

This free online scheduler (basically just a quick Web form) allows you to create an event and set up options for meeting times. You can then send the link to the form that Doodle creates to others to complete, indicating when they are free. You can even choose to get emails when people indicate their availability. What results is a quick list of OKs and red boxes, which makes it easy to spot the best date and time for your event. Just go to the Doodle Website to create your poll. No account is needed.

With so many other ways to keep current (like Twitter), you may not use RSS to keep up with your favorite journals, news sources, and personal interests. If you would like to have one place to go to see the latest *NEJM* articles, view what's happening in the world via *New York Times*, or check if there are any iPads for sale on Craigslist, you can. And all with one click!

Make RSS do the work for you! You can set up a Google Reader account at http://www.google.com/reader to create your personal page. Librarians can help you set up and customize your RSS experience. Use Google Reader on your phone, iGoogle page, or online. Share items with colleagues, make notes, search

# **History of Medicine Collections to Move to Main Campus**

For some time, there have been discussions about the future location of the History of Medicine Collections. A decision has been reached that the Collections will move and become part of the Rare Book, Manuscript, and Special Collection Library (RBMSCL) at Perkins Library, located on Duke's main campus. This was not an easy decision, but it has the full support of the Trent and Semans family members as well as History of Medicine faculty.

A committee of administrators from both the Medical Center Library & Archives (MCL&A) and RBMSCL, along with faculty, has been meeting to address a variety of issues. There will undoubtedly be questions and concerns, but this will be a great opportunity to broaden the reach of the collection and expose more researchers and students to the resources available. The MCL&A will continue to work closely with the History of Medicine Curator and RBMSCL staff to have a presence within the Medical Center, such as exhibit space. The Library will also maintain a core collection of contemporary materials about the history of medicine, as well as a few representative volumes and reproductions that will expose students, faculty, and other patrons to the wonders of older medical works.

The timeline for the actual transition is still fluid at this point, though the current goal is to move the materials and services during the summer of 2011. Please watch our Website and future issues of this newsletter for updates on the move.



Natural Standard was founded by healthcare providers and researchers to provide high-quality, evidence-based information about complementary and alternative therapies. For each therapy covered by Natural Standard, a research team systematically gathers scientific data and expert opinions. Validated rating scales are used to evaluate the quality of available evidence. Information is incorporated into comprehensive monographs which are designed to facilitate clinical decision making. All monographs undergo blinded editorial and peer review prior to inclusion in Natural Standard databases.

"Changing the Face of Medicine: Celebrating America's Women Physicians" will be on display at the Medical Center Library February 14 - March 27, 2011. This traveling exhibit, created by the National Library of Medicine, honors the lives and achievements of women in medicine. Through a series of displays and multimedia kiosks, the exhibit looks at the lives of women in various medical fields, including those who confronted prejudice, made discoveries, effected change, and offered other remarkable contributions.

Women profiled in the exhibit include Dr. Elizabeth Blackwell, the first female M.D. in America; Susan La Flesche Picotte, the first American Indian M.D. in the United States; and Frances Connelly, the first female appointed as a fully tenured neurosurgeon at a United States medical school.
