CURRENT STATUS OF THE "PHYSICIAN'S ASSISTANT"

The variety of names used to identify graduates of experimental educational programs for new assistants to the physician partially illustrates the diversity in this field: Clinical Associate, Medex, Child Health Associate, Physician's Assistant, Community Health Medic, and Medical Services Assistant to name but a few. These and other programs listed in this bulletin vary in their length of training and their requirements for entrance; some programs are designed to utilize the background of former military corpsmen and some recruit people with various backgrounds in the health field. Still other programs, not listed here, but often included in references to the "physician's assistant" concept, are designed to offer additional training to the nurse. These diverse efforts begun by various educational institutions are producing many different kinds of "physician's assistants" to function at different levels of responsibility across a wide range of medical fields.

The American Medical Association strongly supports the concept of innovation and experimentation in utilizing health manpower. However, as the principal agency responsible for accreditation of allied medical education, it is one of the AMA's primary responsibilities to identify the need for additional categories of health manpower: specifically, what new tasks should be performed in a new occupation, and to what extent new categories of health personnel will be employed and accepted.

The AMA Board of Trustees and its Council on Health Manpower have recommended the following as a working definition of the term "physician's assistant" or any other term that indicates a new health occupation with qualifications other than those of a licensed physician working in the capacity of an assistant to such a physician: "The physician's assistant is a skilled person qualified by academic and practical training to provide patient services under the supervision and direction of a licensed physician who is responsible for the performance of that assistant." Moreover, there is strong perference within organized medicine for use of the term "physician's assistant" as opposed to "physician's associate", since use of the latter term commonly implies another physician and is therefore confusing.

Specific job descriptions listing potential functions and responsibilities for personnel developed to assist the <u>orthopaedic surgeon</u>, <u>urologist</u>, and more recently, the <u>internist and family physician</u> have been endorsed by the AMA Council on Health Manpower as developed by representatives of the following medical specialty organizations: American Academy of Orthopaedic Surgeons, American Urological Association, and (jointly) the American Society of Internal Medicine, American Academy of Family Physicians, and American College of

Physicians. Essentials of an Approved Educational Program for Orthopaedic Physician's Assistants and for the Assistant to the Primary Care Physician have been completed and ratified. Essentials for the education of Urologic Physician's Assistants are in development. When Essentials are ratified by the collaborating medical specialties and the AMA House of Delegates, educational programs which meet or exceed their criteria may be approved by the AMA Council on Medical Education.

The legal status of "physician's assistants" has been defined by a number of state legislatures. Two regulatory mechanisms for "PA's" have been proposed or enacted. Both vest authority in the State Board of Medical Examiners, or similar state agency, to regulate "physician's assistants" or classes of nonlicensed allied health personnel trained to perform services in a dependent relationship to physicians. One mechanism provides an exception to the state's Medical Practice Act that codifies the physician's legal right to delegate routine patient-care functions to qualified non-physicians. The following states have enacted such exceptions: Arizona, Arkansas, Colorado, Connecticut, Delaware, Florida, Kansas, North Carolina, Oklahoma and Utah. In the following states, legislation has been enacted to authorize the State Board of Medical Examiners to approve training programs for "physician's assistants" and approve a physician's use of no more than two graduates of such programs: Alabama. California, Florida, Iowa, New Hampshire, New York, Oregon, Washington, and West Virginia. In the following states, comparable legislative proposals are or were pending in 1971: Alaska, Illinois, Indiana, Maryland, Michigan, Minnesota, Nebraska, Ohio, Pennsylvania, Tennessee, and Wisconsin.

At present there are no uniform standards for national recognition of "physician's assistants" offering assurance of minimal performance qualifications. However, standards for the education of selected categories as noted above have been established by the AMA Council on Medical Education. The AMA Council on Health Manpower is developing the mechanism to establish a national program for the certification of assistants to the primary care physician. In the meantime, questions regarding the legal status of "physician's assistants" should be directed to your local state legislature or state medical association.

AMA APPROVED EDUCATIONAL PROGRAMS

As of July 1971, a total of 2,513 educational programs have been accredited by the AMA and collaborating organizations for *thirteen of the eighteen allied medical occupations listed on the next page. Educational Essentials for the remaining occupations have just recently been endorsed or are still in development. MILITARY TRAINING PROGRAMS for physician's assistants:

The AIR FOREE has a requirement for 150 PA's. Classes of 25 will start every four months until requirements are met. The first class began July 1, 1971. The program is located at Shepard Air Force Base, Wichita Falls, Texas. A minimum requirement for students is two years of experience in contact with patients. The course will be of 24 months ouration with 12 months of academic study and 12 months preceptorship. Graduatas will thave a senior non-commissioned officer rank. For more information write Col. The ARMY has a requirement of 400 PA's. Classes of 60 will begin every six months. The first class will begin in February, 1972. The program is located at Fort Sam Houston and is affiliated with Baylor University in order that two years of college credit may be obtained. The course is the same length and general structure as the Air Force program. Graduates will be warrant officers. For more information write Col. NAVY requirements and plans are not yet completed. However, they also anticipate a two-year course. The program will most likely be located in Philadelphia and may be affiliated with Jefferson Medical School. Classes are not expected to start until the middle of 1972.
