WELCOME To Our New Deputy Director *Richard A. Peterson (Rick)*


We are delighted to welcome **Rick Peterson**, who will be our new Deputy Director starting March 5. He comes to Duke from the William E. Laupus Health Sciences Library at East Carolina University (ECU) in Greenville, where he first worked from 1977 through 1979 and again since July 1997.



Rick has a very broad range of library experience, which will be a great asset to the Medical Center Library. His first job at ECU was as the Librarian for the Eastern Area Health Education Center. He then went to the Claude Moore Health Sciences Library at the University of Virginia, where he worked in the Reference Department as well as Automated Services. From 1991 – 1997, he was Assistant Director of the Learning Resources Center.

Rick returned to the Health Sciences Library at East Carolina University in July of 1997. While there, he has served in several areas of the library including Electronic Services, Audiovisuals and Informatics, Systems, and Access Services. Since June, 1998, he has been the Associate Director of the Library.

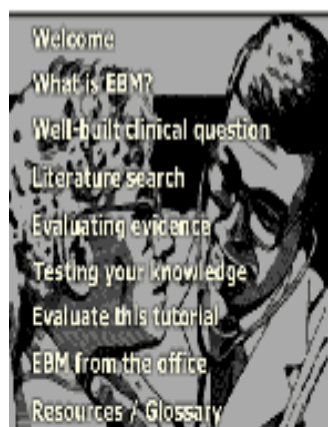
Ovid Tutorial (revised November 2000)

This interactive tutorial takes the individual through the basic steps in conducting a literature search in the Ovid MEDLINE system. The tutorial follows a clinical case, develops the question, formulates the strategy, and then executes the search using the same screens that will be encountered during a real Ovid search.

The revised edition presents a new case and incorporates some of the major changes of the new Ovid version 4.1. In addition to the search strategy, the tutorial provides tips on searching for a specific article by author, words in the title, or journal name. The last section offers access to a number of documents that provide additional information about searching MEDLINE through Ovid.

The Duke Medical Center Library has made this tutorial available to libraries around the world. As a result, it has received very positive evaluations and comments from clinicians, librarians, and students from a variety of medical schools.

The Evidence-Based Medicine (EBM) Tutorial was developed as a joint project between the Duke Medical Center Library and the Health Sciences Library at the University of North Carolina-Chapel Hill. It was created for the NC AHEC system as a way of introducing the concepts of EBM to clinicians practicing in community settings.

The tutorial provides basic information and explanations of the steps in the EBM process. Two additional practice clinical cases have been added to the new version. Users are asked to choose the best clinical question and search strategy for the clinical case. They are then asked to determine the validity of an article addressing the clinical case. The validity criteria are based on the "Users' Guide to the Medical Literature" series of articles published in *JAMA*. Pop-up windows provide immediate feedback to multiple choice questions.

Changes in TRLN Borrowing Program

Borrowing library materials from UNC-Chapel Hill, NC State, and NC Central is now a little simpler for Duke University Library patrons. The Triangle Research Libraries Network (TRLN), comprised of the four universities named above, has implemented new borrowing procedures for its member institutions effective January 1, 2001.

The big change is that patrons of the member institutions do not have to obtain a special TRLN borrower's card from their home library before going to another TRLN library to request materials. Instead, a current University ID card may be presented by the patron at the other library. The visiting patron's institutional ID will be verified using the library patron's record. The same card and number will be used as the basis for borrowing privileges at the other TRLN library, after the registration process is completed.

This means one less plastic card to carry around. Each member library will follow its own procedures for registering visiting TRLN patrons and creating a borrower's record. For example, new patrons may be referred to central libraries for registration prior to obtaining borrowing privileges at branch libraries.

Eligibility for borrowing will be reverified and borrowing privileges renewed on a regular schedule. Student privileges will expire on August 15 and December 31 of every year. Faculty and staff privileges expire annually on December 31.

Ovid Adds Full Text in PDF

If you are currently using our E-journals page (<http://www.mc.duke.edu/mclibrary/respub/collections/ejrn.html>) to locate full text articles from journals available via Ovid, you may now be able to retrieve some of those articles in Portable Document Format (PDF).

Since October/November 2000, the additional PDF option has been added to 118 of Ovid's 370-plus titles in the Journals@Ovid database, including the *New England Journal of Medicine* and *Circulation Research*. Presently, the Library subscribes to approximately a third of these titles. More titles are expected to be added throughout 2001. Eventually, Ovid hopes to offer PDF for all the titles in Journals@Ovid.

Please note: PDFs are being supplied (somewhat slowly) by Ovid's publishing partners and will not be added retrospectively. If the PDF format is available, it will appear below the *Output* options after clicking on the "Ovid Full Text" link when viewing a current list of titles. The PDF format, accessible using Adobe's freeware Acrobat Reader, is not searchable, but offers a replica of the article as it appears in print.

Jon Auman, Network Administrator, Information Technology Services, left the Library in November to take a position at Analysts International in Cary. Jon had worked at the Library since 1999.

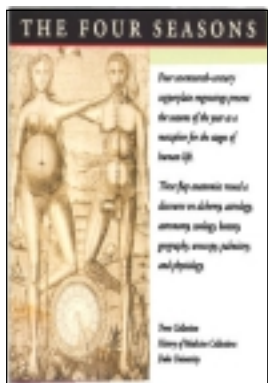

She assisted the Library in its implementation of two online catalog systems, worked on a TRLN task force for the creation and standards of the MARC format for holdings, and developed guidelines for cataloging our newest electronic resources. Janie's commitment to high quality cataloging and classification has strengthened accessibility to the Library's resources.

In addition to her activities at Duke, Janie has been very active professionally on a local, regional and national level. In 1999, she was the recipient of the "Marguerite Abel Service Recognition Award," given annually by the Mid-Atlantic Chapter (MAC) of the Medical Library Association (MLA) for exemplary service to the Chapter.

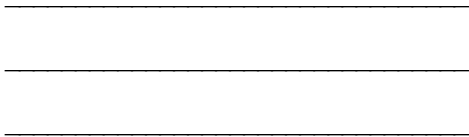
