# CHARTER OF THE SUBCOMMITTEE ON THE PHYSICIAN AND HIS ASSOCIATES IN HEALTH

#### I. Purpose

The Subcommittee shall advise in an ad hoc capacity, the Personal Health Services Ad Hoc Advisory Committee, on the development of a position paper on the health auxiliaries or physician assistants.

#### II. Subcommittee Charge

The Subcommittee will prepare a position paper outlining the purpose, need, qualifications criteria, training and projected utilization of physician assistants and/or health auxiliaries.

## III. Subcommittee Structure

Chairman William DeMaria, M.D., will appoint members to the Subcommittee in sufficient numbers deemed necessary to achieve the
objectives so stated in this charter, and these members need not
be on the Personal Health Services Ad Hoc Advisory Committee.

A Bureau of Health Services staff member will serve as the Executive
Secretary.

## IV. Subcommittee Operations

The Subcommittee will conduct its program principally by mail; however, when meetings are required, they will be called by the Chairman and coordinated with the Bureau of Health Services. Minutes of the Subcommittee's meetings will be made and distributed to members by the Committee Chairman or his designee within fourteen days of the completion of the Subcommittee's work.

#### V. Subcommittee Objectives

The Subcommittee will develop and present to the Personal Health Services Ad Hoc Advisory Committee a position paper on the physician and his associates in health and/or health auxiliaries. The paper will address itself principally to the following elements:

- The purpose and need for the development of physician assistants;
- Extension of the physician-nurse professional relationship to provide greater responsibilities to nurses;
- The Admino-Tech qualififcations, training, and position description; and
- 4. The realignment of the two major components in health care, the personal and the technical, to accommodate the super-nurse and Admino-Tech concept.
