Making Way for the New SOM Learning Center

The construction of the School of Medicine (SOM) Learning Center has begun! The new building will not only be adjacent to the Library, but it will actually connect into the Seeley G. Mudd building, with walkways on what will be the second and third floors, currently the Entrance Level and First Stack Level of the Library.

As part of the renovations, offices to support the SOM curriculum will become part of the Library's third floor, which means storing, moving, and consolidating some of the current collection in the Library.

To prepare for the renovations, the Library is undertaking another review of its collections to identify the materials that need to be kept on our shelves for current use, stored at the Library Service Center, or possibly discarded. Library staff members are carefully reviewing each book title to determine its importance to Duke Medicine, how it might capture the history of various fields and subspecialties for future research, and whether duplicate copies are available on campus. The plan is to keep all books published since 2002 and all heavily used titles in the



Library. Journals volumes that are available electronically or published before 1994 may be moved to Duke's Library Service Center.




Remember the Milk Free Task Manager

Is your desk cluttered with sticky notes, to-do lists, and calendars? Well, Remember the Milk (https://www.rememberthemilk.com/) can help! This free online tool lets you create to-do lists to help in planning and prioritizing your day. Using Remember the Milk, you can assign tags, notes, and due dates to tasks. You can also organize tasks by type, such as personal, study or work, and send yourself email or IM reminders about upcoming meetings.

The service is flexible, too. Tasks can be added from anywhere, viewed on Apple iCal or Google Calendar, or synchronized with Microsoft Outlook, Blackberry, or Windows Mobile accounts.

With Remember the Milk, you can share your tasks and lists with contacts, or use the map feature to pinpoint the location of appointments, meetings or errands. If you want to lose the desk clutter and get organized, give Remember the Milk a try.



WolframAlpha

Data, Statistics & Calculations Search Engine

WolframAlpha (http://www.wolframalpha.com/) bills itself as a computational search engine. Rather than simply finding the terms on a Web page, this program applies mathematical and logical algorithms to your search terms.

WolframAlpha indexes many data sources to provide charts and statistics for your results. For example, a search on "prostate cancer" would not yield information about prostate cancer treatment or life with prostate cancer. Instead, results would include the ICD-9 code and statistics on patients diagnosed with prostate cancer in a given year, reasons for the patients' visits, drugs prescribed at the visit, and characteristics of the patients.



Firefox Add-ons Customizations for Your Browser

Firefox has thousands of add-ons available at https://addons.mozilla.org/en-US/firefox/ to enhance, improve, and customize your browser experience. An add-on can be a time-saving toolbar button, security enhancement, themed look, and more. For example, LeechBlock is a productivity tool designed to block Websites that can suck the life out of your working day. All you need to do is specify which sites to block and when to block them.

If you work at more than one computer, check out *Xmarks*. This will keep bookmarks and open tabs synchronized across computers. *Session Manager* can be a lifesaver by saving and restoring all your open windows after a crash. Choose add-ons for the way you browse. Installation only takes a few clicks. Explore and add on now!

Demystify Our Images

"Demystify Our Images" (http://digitaldukemed.mc.duke.edu/mystery/), a popular interactive exhibit, was initially rolled out in 2008 as a joint project between the Duke Medical Center Library and Archives and the Duke Medical Alumni Association. It was advertised through the Archives' newsletter and the Alumni publication, *DukeMed Alumni News*. The initial response to the exhibit was extremely positive.

The unique and useful aspect of this exhibit is that it gives visitors an online forum to examine unidentified images from our collections and immediately provide us with feedback. Users are allowed to post information or comments about a particular image directly to the site, much like a blog.

The Medical Center Archives has recently completed a migration to Drupal, a new open source Web platform for our Website, online exhibits, and departmental newsletter. The new Drupal platform has made it easier to add images and update the site with more regularity.

We are excited to hear what you think about this exhibit, as well as our new Drupal platform. So please stop by online and take a look!
