Statement of Problems:

I. The American Academy of Physicians' Associates and the Association of Physician Assistant Programs need financial support. Both professional organizations are nonprofit, federally tax exempt, and to date have operated on monies received from their respective memberships. No "private" financial support has yet to be received by either group. Monies received provides for the cost of printing, supplies, postage, and etc., but not in support of offices, staff, and etc. If objectives are to be reached in reasonable time - and the P.A. concept/movement to benefit maximumly - it is felt that monies will be necessary to support staff and "national" offices.

Statement of Objectives:

I. To seek financial support to staff and maintain a "national" office.

II. To reach objectives of mutual concern as follows:

A.) To educate professional and lay people regarding the P.A. concept and its implications.

B.) To serve as an information center to groups concerned with the "P.A. business" such as State Medical Societies, A.H.A., and etc.

C.) To assist the American Medical Association in the accreditation of P.A. programs and the National Board of Medical Examiners in the production and implementation of a certifying examination.

D.) To develop and enforce continuing educational programs for the Physician's Assistant and the Academy membership.

E.) To assist with the coordination and standardization of curricula for Physician's Assistant programs (but at the same not to impede nor hinder the development of innovative methods of training allied health manpower).

F.) To establish a "central register" of employment offers for Physician's Assistants by working closely with all Physician's Assistant programs.
