Dear Colleagues,

Thank you for your response to our letter of November 24, 1972. Your personal reply will be forwarded but the nature of some of the response makes it necessary in this communication to clarify the first paragraph of November's letter.

It was not our intent to be interpreted as stating or implying that the American College of Physicians Assistants had been recognized as the sole representative of physician's assistants by the American Medical Association - this interpretation would be presumptuous. In perhaps clearer terms may we restate the intent of the paragraph concerned. Our past and our current exposure to the American Medical Association as we see it is leading our organization successfully toward that day when the physician's assistants will be a recognized entity on a national representation basis. The American College of Physicians Assistants assumes this goal as our responsibility and is looking toward the day when it will be a physician sanctioned organization which represents physician's assistants professionally.

Now onto other business. In the quest of the College to represent its members and to have positive input in the destiny of the physician's assistant, we recently submitted a preliminary recommendation to the National Board of Medical Examiner's Study Committee concerning the Certifying Examination for physician's assistants and who is eligible to sit for the first examination. Barbar J. Andrew, Ph.D., Director-Division of Allied Health Evaluation, forwarded a letter of appreciation for our input in which she stated, "In reviewing your position statement, there appears to be a considerable compatibility of views on this question." She also said that our preliminary recommendation would be under consideration by the Special Study Committee on Eligibility and that the results of their meeting would be forwarded to the College. Again we feel encouraged that our line of thinking appears to be coordinated with those appointed individuals whose task it is to structure this important aspect of physician assisting. Any concrete suggestions on your part will be most appreciated by the College and will be forwarded to those areas where they will be most beneficial to the physician's assistant profession.

The College has just received a physician's assistant salary survey along with position availability information (both being of great interest) from The Arkansas Regional Medical Program, 500 University Building, 12th at University, Little Rock, Arkansas 72204.

and several others among whom were members and advisors of the College and a representative of the Academy, faculty members of a local physician's assistant academic program, and physician's assistants in the area.


