The Office of Medical Education has received information from National Medical Fellowships, Inc. concerning the Commonwealth Fund Fellows Program which is designed to encourage academically gifted minority medical students to pursue careers in academic medicine and biomedical research. In 1984, up to 20 third-year minority medical students will be selected. The Fellows will spend 8-12 weeks during the third year working in a major research laboratory. The student must identify a senior scientist willing to serve as a mentor/advisor.

- Bob St. Peter called the meeting to order at 5:30 p.m. Roll was called with the following members absent: MS II - Spach, Branum, and Glaze; MS IV - Smith, Rustgi, and Benyunes. Condensed minutes were read and approved unanimously.
- II. Old Business Family Medicine Grant Letter This topic well be discussed at the next meeting due to lack of time tonight.

III. New Business

- A. Student Group Affiliation
 - 1. Previously affiliated organizations were re-affiliated unanimouly.
 - 2. New groups requesting affiliation were also approved: Amnesty International unanimously, AOA unanimously, and the AAMC Organization of Student Representatives by a vote of 19-2.
- B. SNMA Budget Request Tanya Trippett, President presented her group's views to the Davison Council. She focused on the request for \$800 to help elicit funds for the Meriwether Scholership, an endowed scholarship for black medical students. Jennifer Ruh presented the Budget Committee's consensus that although it is a very worthwhile project, it would set a bad precedent to spend limited student resources for funding a student scholarship. Others expressed a willingness to give the money as a loan to help support fund-raising efforts already underway. In the end it was voted unanimously to add \$30 to the \$870 recommended by the Budget Committee plus \$100 for the scholarship. \$1845 had been requested from the Davison Society by SNMA.

- D. Budget Committee Presentation The Budget Committee this year included Treasurer T.J. Maroon, Jennifer Ruh, Steve Feldman, Jodell Boyle, and Bob St. Peter, all of whom had spent nine hours reviewing budget requests. T.J. presented the overall budget picture to the Council. Projected Revenue was \$7631.95 most of which came from the \$15 per student per year Davison Society Dues. Requested expenses totaled \$12,626.00, giving a total deficit of \$4994.05. From the budget requests, the committee recommended a \$9913.00 expenditure (about \$20 per student), giving a recommended deficit of \$2281.05. The deficit would be covered by dipping into funds in the Society's treasury amassed over previous years.
- E. Fixed Expenses Money for a typist, telephone, office expenses, freshman orientation, lounge fund, and Xeroxing were approved unanimously for a total of \$1540 as recommended.
- F. Service It was noted that in the past there has been poor to no record-keeping for the Senior Award, Kinney Award, and Golden Apple Award. A total of \$800 was agreed on for awards and for the Service Vice-President's budget, deleting \$100 from the Golden Apple Award due to less than anticipated expense.
- G. Social
 - Vigorous discussion followed Bob Sherrier's request for \$2900, more than the \$2500 suggested by the Budget Committee. \$200 of the deletion by the Budget Committee was due to the lack of the proposed Halloween Party. The allotment of money to

- III. G. 1. individuals for school-wide parties at their houses, so called "house parties," was argued back and forth. A motion that \$2500 be given to the Social Vice-President was passed 16-7, with those opposed supporting more money for social events. Several Council members suggested that Davison Society dues be raised since they have remained the same for ten or more years.
 - 2. Class budgets. \$400 per medical school class and \$200 for the M.D.-Ph.D. class for social activities was approved unanimously. Mark Rosenberg argued for an increase in the M.D.-Ph.D. budget.
