WILLIAM OSLER MEDAL - The American Association for the History of Medicine announces the student essay contest for 1974. The William Osler Medal, plus a prize of \$200.00 is awarded for the best unpublished essay on a medico-historical subject written by a student in one of the medical schools in the United States or Canada. All students who are candidates for the degree of Doctor of Medicine, or who graduated in 1973, are eligible, but the essay must have been written while a contestant was an undergraduate in good standing. The winning student will be invited to attend the annual meeting of the American Association for the History of Medicine and will receive an additional \$200.00 to defray travel expenses. Essays appropriate for consideration by the committee include both those involving the historical development of current medical problems and those dealing with medical problems of a discrete past period. The essay should demonstrate either original research or an unusual appreciation and understanding of the problem or situation discussed. Each essay must be entirely the work of one contestant. No outside help may be accepted, other than the usual courtesies extended to all investigators by libraries, museums, historical societies, and other institutions. Maximum length is 10,000 words. The deadline for receipt of essays is March 1, 1974.
