# Reflections of Past

In the opening of the Plenary Session Monday morning Frances L. Horvath, M.D., President of the Association of Physician Assistant Programs narrated a very special program for the American Academy of Physicians' Assistants-Reflections: AAPA Past Presidents.

The program highlighted the accomplishments of the Academy during the past ten years and featured all the AAPA Past Presidents. Each spoke of his recollections of his term or terms in office.

William Stanhope, who served as the Academy's first president from 1968 through 1971, reviewed what he called the "fragility" of the profession and the Academy. He described the almost impossible tasks facing the first Board of Directors in 1969, and told in detail of how they were able to set in motion goals that today are still being acted upon.

Tongue in cheek, Stanhope noted that a goal of "more regular board meetings" was the only one that does not still need work, adding, "I have recently been hearing talk that there have been too many board meetings!"

Each Past President following Stanhope took a brief time to describe his own term of office. John McQueary, Tom Godkins, Paul Moson, Carl Fasser, Whittaker, and Dan Fox all brought the audience through ten years of history in a manner which was interesting as well as informative.

They described the history of the name changes in the Academy; the formation of the first regional chapters; the many struggles for

Good Subjects-Speakers

### Plenary Session Rated 'Best' by PA Audience

Monday's Plenary Session, beginning with the morning panel discussion The Real Issues of Your Profession and ending with a session on Tracing Your Roots: Past, Present and Future, proved to be one of the day's most attended group meetings.

As one attendee described it, "One of the best line-ups of subjects . . . and by speakers I most wanted to hear the subjects from."

Henry Silver, M.D., Professor of Pediatrics at the University of Colorado School of Medicine was on the morning panel to discuss What's in a Name: PA-PA-MLHCP: HELP. According to Dr. Silver there is a need to clarify terminology used to describe and/or designate various categories of health professionals. His portion included a recommendation that one of two names, Synatrist or Health Care Practitioner, be adopted as a generic name for all health professionals who perform functions traditionally performed by physicians.

Physician Assistant Vs. Surrogate Physician was the panel topic of E. Harvey Estes, Jr., M.D., Professor and Chairman of Duke University Medical Center's Department of Community Health Services. The presentation of Dr. Estes addressed

the issue of more complete autonomy for the physician extender—a posture supported by nursing for nurse practitioners. He described the various professional profs and cons on the subject including what he called a "politically and professionally detrimental" trend calling for "a masters level program of training, leading to an independent type of primary care practice."

The third panel speaker, Robert Robards, M.D., Vice President for Medical Relations for the National Pharmaceutical Council, approached a subject close to all physician assistants, Prescribing: A Privilege and Responsibility. Through a straightforward presentation of facts and figures, Dr. Robards examined the power which is conveyed through the issuance of prescriptions. A major emphasis of his talk concerned the cost effectiveness of rational drug therapy.

Following the break at the end of the panel discussions, Jackson Riddle, M.D., Ph.D., Director of the Division of Education Policy and Development of the American Medical Association, presented the topic of Professional Ethics. Dr. Riddle went into the historical antecedents of professionals ethics, their relationship to the law, and an exploration of using current medical ethics as a basis for the ethical behavior of physician assistants.

The final speaker before lunch was Sam Romeo, M.D., the Medical Director of the Family Medical Center in Pocatello, Idaho. Dr. Romeo is also the recipient of the AAFP Outstanding Physician Award for 1977. His topic, Your Role in Private Practice, dealt with the introduction of the physician assistant into the office practice setting. Dr. Romeo sees a direct impact on the productivity and efficiency of an office practice under

these circumstances. He noted that "the physician assistant enhances the quality delivery of medical care," but added "the reality of health care delivery and enhancement by the PA must be tempered and judged with an eye towards economics."

Approaching a subject which he claims most of society "avoids," the Executive Director of the Boston Center for Religion and Psychotherapy, Inc., Mwalimu Imara, D.Mn., spoke forcefully on Counselling the Terminally Ill Patient. He described many of the thoughts, fears and loneliness experienced by those who are faced with an impending death. Pointing out that as caring professionals, we can gain much by dropping our masks (hiding us from the terminally ill) and allowing the seriously ill and bereaved to share their deepest feelings with us . . . '' Dr. Imara sees this step by the medical community as the only way to attain a similar step by society in general.

Dr. Imara revealed a dedication to his feelings during a brief interview prior to his presentation when he noted that remuneration from his talks across the country is used to help support his center where about forty percent of the work is being done on a charitable basis.

An Associate Professor of Family Medicine and Dentistry at the University of Oklahoma Medical School, William D. Stanhope, P.A., gave the final presentation of the day, The PA Profession: Past, Present and Future. Stanhope reviewed the historical developments within the physician assistant concept, on both a national and international level. He gave prognostications as to the direction of the profession in the future.

### New APAP President Installed

The newly installed President of the Association of Physician Assistant Programs, Archie Golden, M.D., stated Monday that the future of APAP must hold a shift in goals to assure quality education of physician assistants especially in light of changing laws regarding prescriptive practices for PAs.

Speaking at the APAP Business Meeting, Golden said that APAP members can look forward to receiving increased support in terms of specially designed workshops and faculty development activities in the next year.

Golden stated two specific objective for the Association: better funding for PA training programs, and ensuring legislation through Congress to provide for student scholarships and loans. The second objective may take until 1980 to accomplish, he acknowledged.

In addition to Golden, other new APAP officers to take the reins for the coming year are: Thomas R. Godkins, P.A., President-Elect, David E. Lewis, Ed.D., Vice President; and Karl Katterjohn, P.A.-C., Secretary/Treasurer. The election of Mr. Godkins as president-elect of APAP marks a first for this organization which has historically been presided over by physicians.
